

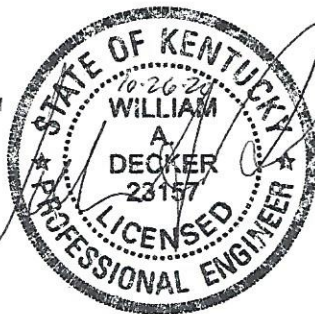

In accordance with 40 CFR 112.5(b), the facility must review the SPCC portions of the plan at least once every five years following certification and implementation of the original plan.
